• Brief Definition of IFPSM: IFPSM is a non-political, independent, and non-profit oriented international umbrella organization that unites national and regional Purchasing and Supply Management associations worldwide. It connects 40 associations and reaches around 250,000 professionals.

"To increase the ability of IFPSM's network of member organizations to connect, to collaborate, to share best practices, and to enable them to be more effective in serving their members and the profession."





Vission

"IFPSM is the global, leading platform in procurement and supply chain management, which serves the development of the profession and member organisations".





Key Areas of Operation



- **Professional Development and Knowledge:** Facilitating the development and distribution of knowledge **to elevate the profession**.
- Global Standards (GS) and Programme Accreditation Standard (PAS): Developing and promoting global quality standards for educational programs in the supply chain (e.g., the IFPSM Global Standard and PAS).
- Global networking, Events: Organizing high-level events, such as the annual IFPSM World Summit, for the exchange of expertise and networking.
- To promote **corporate procurement governance** in the purchasing function and emphasize its vital role in increasing efficiency and transparency in business.

Key Areas of Operation





- Raising the Profile of the Profession: Striving to improve business practices that favourably impact the standard of living worldwide.
- Best practice, knowledge and research sharing: To facilitate the exchange of information on next best practice standards and technology tools through education, publications and events
- **Professional exchange** and collaboration projects: To continuously assess and improve the PSCM by providing venues for benchmarking and exchange of ideas. To **promote corporate procurement governance** in the purchasing function and emphasize its vital role in increasing efficiency and transparency in business.
- Partnerships with institutions and academia: To promote and foster partnership with Global Institutions which set and regulate PSCM practices between countries and trading blocks, that we can advise and motivate their policies and execution (EU, ASEA, AU, World Bank,....) to increase IFPSM's influence.

 Opinions were checked in different countries: registration cost, law, cost of administration






Why Transformation Was Needed
